## Item 4: Dispute Resolution Committee Oversight (45 minutes)

Discussion: We propose to require Oversight and Transparency for the Dispute Resolution Committee, and add the right to appeal decisions in cases of misconduct and violation of DRC guidelines Any judicial system requires checks and balances. As of now, there is no formal way to appeal or question the Dispute Resolution Committee's decisions or any way to file a formal grievance about their actions. The committee claims its decisions are final and cannot be appealed. They also claim the right to withhold evidence or even formally name accusers. As a result, we propose the ability for a member to report directly to the Hearing Administration Committee when pertaining to issues involving the DRC. As currently constructed, the DRC will not hold a hearing involving themselves or one of their own committee members. —submitted by Malcolm Armstrong
